Dear Governor Bentley:

Thank you for your letter of August 7, 2013, requesting a disaster designation for Alabama counties that suffered losses due to excessive rain and flooding that has occurred in 2013.

The U.S. Department of Agriculture reviewed the Loss Assessment Reports and determined that there were sufficient production losses in 50 counties to warrant a Secretarial natural disaster designation. Therefore, I am designating 50 Alabama counties as primary natural disaster areas due to damage and losses caused by excessive rain and flooding that occurred during the period of January 1, 2013, and continuing. Those counties are:



A Secretarial disaster designation makes farm operators in primary counties and those counties contiguous to such primary counties eligible to be considered for certain assistance from the Farm Service Agency (FSA), provided eligibility requirements are met. This assistance includes FSA emergency loans. Farmers in eligible counties have 8 months from the date of a Secretarial disaster declaration to apply for emergency loans. FSA considers each emergency loan application on its own merits, taking into account the extent of production losses on the farm, and the security and repayment ability of the operator.

Local FSA offices can provide affected farmers with further information.
